PLEASANT LIFE stalked the pace, moved up along the inside in the lane and finished gamely to get up under all out pressure. MINGUN'S PEACHES set all the pace and gave way grudgingly to be second best. BRASSY TOUCH was slow early, moved up seven wide into the upper stretch and made a good late gain. CANDY PAINT took up sharply early, moved up five wide in the stretch and showed good late interest. RIDGEOFSTONE stalked the pace from the outside and weakened in the final stages. WONDER COUNTRY stalked the pace and tired. CABINETS INCLUDED pressed the pace and gave way. SHE'S THE CAT failed to respond. SAPPHIRE SUE showed little. SAJANI settled off the early pace and was always back. ADONICA was unhurried early and never was involved. RYAN'S MIRACLE raced far back and never threatened.
