**Footnotes**

BURST OF LIFE stalked the early pace three wide, looped rivals on that path through the turn and bid just outside the pace setter, then drove clear late. PERSONAL REGARDS set the pace on the outside, gained a clear lead at the quarter pole, then shortened stride in the lane and weakened late. AMAZON WALL chased the pace on the inside, angled out to bid four wide into the stretch, then could not gain the final furlong. LADY SISTER ANNA chased the pace off the rail, was blocked into the stretch, drifted in in the lane and could not gain. ELATED PRINCESS vied for the early lead inside and had no stretch rally. YULE GO BLACK TIE ran evenly. LUMPASUGAR bumped at the start, showed little. WINNER TIME FROST well placed and widest, faded quickly. BLUE GENE SONG was no factor. DIXIE LORENA broke slowly and trailed the field.
