MAJORCA SUN sprinted to a clear lead soon after the start, increased his lead while never being challenged, then drew off in the lane under steady pressure. SEEKING THE REWARD well placed and four wide, angled in into the turn and moved up, bid on the two path into the stretch and edged ahead late for the place while no threat to the winner. TWO LEFT SHOES chased the pace off the rail, angled in into the turn, then closed willingly through the lane to be clearly best of the rest. UNCHAIN THE TRAIN broke in at the start, moved up inside through the turn, angled out to bid between rivals into the stretch and rallied up for a share. RISK DRAG well placed between rivals, came three wide to bid and steadily lost ground. K B'S REALITY had an inside trip. CURZON STREET was never involved, inside. UNLAWFUL DETAINER no factor, widest.
