MUSICAL DEPUTY sent from the gate, vied for the early lead outside, bid just outside the pace setter, dueled with that one to the final furlong, gained a clear lead and increased under steady pressure. L G SUPREM mid pack and inside, moved up through the turn, angled out slightly in the stretch and closed well to gain the place while no threat to the winner. APPEALS THE DEAL set the early pace on the inside, dueled with the winner and weakened the final furlong. LIONS COURT stalked the early pace on the outside, dropped back slightly through the turn, came three wide to bid and weakened in the drive. MANLEE SPIRIT void of speed, came four wide to bid and improved his position. BOLD RAIDER mid pack and outside, gained position through the turn and faded in the drive. DE BALA showed little. WILLOW PARISH ran evenly. BREAKING BARRIERS passed tiring rivals. SLYDING BY was a brief factor. MAN OF DUBAI was no factor. BIG WILLO well placed and outside, drifted out badly into the stretch and faded.
