Footnotes

FLOODGATE angled in sharply after the start to force the pace outside foes three deep racing to the bend, continued outside a rival on the bend while gaining a narrow advantage, drifted out in upper stretch, but continued resolutely under pressure to prevail while drifting some more in the final sixteenth under brisk left handed pressure. BORJA tracked the leaders four deep in the second flight to the bend, advanced in that path to challenge nearing upper stretch, drifted out near the sixteenth marker impeding OWEN'S CHOICE but continued under pressure for thee place. MARKY P tracked the leaders from out of striking distance along the inside in early stages, advanced to contention while negotiating some close quarters nearest the rail to challenge in upper stretch and continued willingly to the end for a share. OWEN'S CHOICE was held up just after the start to track the leaders, split foes readily advancing to striking distance on the bend, was steadied out off FLOODGATE entering upper stretch, altered course to the outside, then was forced out in the final sixteenth by BORJA while losing some momentum. RIGHTEOUS THUNDER was steadied a bit off a rival start, tracked the pace unhurried and never gained striking distance. PLEASANT PARTNERS was outpaced early, improved his position ion the turn but had no final response. ROWDY REPORT dropped out early. OUT FRONT was urged to dispute the pace along the rail and gave way after a half. TEXAS ROSE flashed brief pace between foes but gave way abruptly after three furlongs. FOLLOWING THE RACE THE RIDER OF OWEN'S CHOICE LODGED A CLAIM OF FOUL AGAINST THE WINNER. THE STEWARDS CONDUCTED AN INQUIRY INTO THE STRETCH RUN AND DISQUALIFIED FLOODGATE, PLACING HIM THIRD AND DISQUALIFIED BORJA, PLACING HIM FOURTH.
