Footnotes

STAMP OF APPROVAL vied for the early lead outside, moved up to challenge for and gain a short lead through the second turn, shook clear in the stretch and drew off while drifting in. SHARP ANGLE set the early pace inside, could not go with the winner into the stretch, stayed on to be clearly best of the rest while no threat to the winner. TIGERSTARK void of speed, moved up through the second turn, came three wide to bid into the stretch and passed tiring rivals. SKIP THE HATCHET never far back and outside, looped rivals three wide through the second turn, bid on that path into the stretch and weakened in the drive. TAPINOT tracked the early pace off the rail, drifted out through the lane and faded. CASE SETTLED stalked the early pace three wide and was through after a half.
