Footnotes

BUBBLE B. BUDDHA, brushed at the start, quickly asserted his superiority in the opening quarter, forged clear on the bend and steadily widened his margin under hand urging, then was ridden out in the final stages while increasing his advantage. CALF CREEK SHADOW tracked the pacesetter three wide in the second flight, made steady progress to secure the place but was no threat to the winner. SUE'S N PROMISE raced unhurried off the inside early, angled out nearing the lane and continued well enough to gain a share. PREMIER CABERNET tracked in second flight between foes, made a brief bid on the turn, then steadily faded in the drive. VALIANT AFFAIR passed some tiring rivals late. JONES ECHO flashed brief pace along the inside and gave way after a half. MARCH N NOVEMBER trailed.
