SHE'S THE CAT well placed and outside, gained position on the two path through the second turn, angled out to bid four wide, then made a steady gain through the lane and drew off late under steady pressure. DEAR HRISHI well placed and inside, gained position through the second turn, came through inside of rivals into the stretch, then made a steady gain and hung. THEATRE OF DREAMS stalked the early pace inside, challenged for and gained a short lead into the second turn, then evened out in the lane. PRETTY PENELOPE set the early pace off the rail, stayed in a contentious position when loosing the lead, then weakened the final furlong. GLACIER ISLAND mid pack and outside, moved up on the two path through the second turn and flattened out in the lane. UPTOWN CHARMER allowed to settle, moved up outside through the second turn and ran evenly in the lane. ANDREA'S JOSIE improved her position. AUTUMN IN DUBAI ran evenly. DYNABON was a brief factor. NIKALICIOUS was never involved. TALI CAN DANCE was outrun.
