APPEALS THE DEAL sprinted to a clear lead soon after the start, increased his margin, then drew off in the lane while being kept to the task. MANLEE SPIRIT mid pack and inside, moved to position through the turn, angled out to bid four wide, then closed well in the lane to get up for the place while no threat to the winner. DE BALA tracked the pace on the inside, angled out to bid just outside that one, then weakened in the drive. L G SUPREM well back, moved up inside through the turn, came through inside of rivals, then angled out slightly for clear racing room and got up for a share. KIPSON well placed and three wide, bid on that path into the stretch and faded in the drive. DEMIS LIL' STAR ran evenly. THE RECONCILER well placed and inside, had no rally. GHAZI'S PATCH WORK showed little. SOMETHING LEGAL was no factor. BOLD ADVANTAGE was a brief factor.
