With \$65,000 guaranteed, \$15,000 from Mystic Lake Purse Enhancement Fund with the balance to include nominations, entry and starting fees, of which \$39,000 to the owner of the winner. All other purse monies paid corresponding with purse schedule in Condition Book.

WEIGHT: 122 lbs. Maidens allowed 5 lbs. HIGH WEIGHTS PREFERRED. (WINNERS PREFERRED). (Non-starters least preferred). Total earnings will be used in determining the order of preference of horses assigned equal weights. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A trophy will be presented to the winning owner. Nominations closed Sunday, April 1 with 38. (S)

HELISKIER stalked the early pace outside, moved up to challenge for and gain a clear lead through the second turn, then drew off in the lane in a handy fashion. SUE'S STORMY sprinted to a clear lead soon after the start, could not go with the winner into the stretch, stayed on and held the place safe. TEZ VIRAT well back and outside, gained position three wide through the second turn, bid on that path into the stretch, then drifted in and got up for the show late while no threat to the top two. SPEAKFROMYOURHEART mid pack and outside, gained position on the two path through the second turn, came three wide to bid and evened out. QUOTE TO CASH well back, moved up inside through the second turn, drifted out in the stretch and could not gain. THEPOINTMAN passed tiring rivals. SAM WAYNE well placed and inside, steadily faded. BOBBLE DOIT well placed and off the rail, faded after a half.
