**Footnotes**

SLYDING BY well placed and outside, gained a striking position through the turn, bid between rivals into the stretch, then made a steady gain, drew off the final furlong and held under steady pressure. ROYAL BLUFF well back, moved up through the turn, came through inside, then closed well to get up for the place while no threat to the winner. DEMI'S STAR tracked the pace on the inside, came through inside of rivals into the stretch, angled out for clear racing room and ran evenly. HALL OF JUSTICE passed tiring rivals. AWMA'S DIAMONDS mid pack and off the rail, gained position through the turn, fanned four wide to bid and flattened out. SIGNAL WHEN READY set the early pace inside and faded the final furlong. GHAZILLA was never involved. ORFAN OLE vied for the early lead outside, came three wide to bid and had no stretch rally.
