CHICK FIGHT sprinted to a clear lead soon after the start, turned back a challenge into the stretch, then increased her margin and held under steady pressure. PRINCESS FREEBIE stalked the pace outside, moved up to challenge into the stretch, could not go with the winner, stayed on to hold the place safe. HAREM DANCER stalked the pace outside, bid three wide into the stretch and ran evenly. THUNDER AND BELLE well placed and between rivals, came through inside into the stretch, then weakened the final furlong. HER SWEET SAINT was outrun.
