**Footnotes**

HELISKIER stalked the early pace from between rivals, moved up to bid just outside the early pace setter, drew off the final furlong under mild urging. BOBBLE DOIT tracked the early pace inside, angled out to bid three wide into the stretch, then lacked the late kick needed. CHEAP CHOCOLATE sprinted to a clear lead soon after the start, could not go with the winner in the stretch, stayed on and weakened the final furlong. PERFECT ABLATION void of speed and inside, moved up on the two path through the turn, split rivals in the stretch and closed willingly through traffic to gain a share. ARVINDRA well back and off the rail, came four wide into the stretch and passed tiring rivals. SLYDING BY well placed and four wide, bid three wide into the stretch and faded the final furlong. LAMBDA NU well placed and three wide, drifted in into the stretch and had no rally. THEPOINTMAN showed little, outside. L G SUPREM was never involved. APPEALS THE DEAL rushed up and was blocked, then faded.
