Footnotes

GRANDPA GEORGE tracked the early pace inside, raced boxed through the second turn, was blocked into the stretch, waited, angled out and got through between rivals, then made a steady gain and got up in the final strides. RAJABLOU sprinted to a clear lead soon after the start, increased his margin, then was outfinished in the final strides in a good effort. CHISENAU mid pack and inside, gained a striking position through the second turn, came through inside of rivals into the stretch, then evened out the final furlong. CORPORATE CHARLIE mid pack and outside, gained a striking position three wide through the second turn, came four wide to bid, then weakened in the drive. CAT'S CLASSY RIDER stalked the early pace outside, moved up through the second turn to bid three wide, then faded in the drive. WHISKEY DECISION well placed and off the rail, moved up on the two path through the second turn, fanned widest into the stretch and ran evenly. STALKING LION well back, moved up three wide through the second turn, then had no rally. RED SHOES showed little. HULA KING (GER) was no factor. JIX was never involved. A CLAIM OF FOUL LODGED BY THE RIDER OF CAT'S CLASSY RIDER AGAINST THE WINNER WAS NOT ALLOWED.
