### Footnotes

UNLAWFUL DETAINER mid pack and outside, looped rivals four wide through the turn, fanned widest into the stretch, then made a steady gain and edged ahead in the final strides. BRITE DREAMER set the pace on the inside, shook clear through the turn, then could not match the winners stride late while holding the place safe. WENTZVILLE MAN tracked the pace on the inside, gained a striking position through the turn, came through inside of rivals into the stretch and lacked the needed late kick. BIG CHEER stalked the early pace outside, gained a striking position through the turn, came three wide to bid and weakened the final furlong. HARLEY MAN improved his position, inside. ESTRELLA DE ORO passed tiring rivals. WILDWOOD ARAGORN well placed and three wide, looped rivals on that path through the turn, came four wide to bid, then drifted in and faded in the lane. BROTHER CANNNES was a brief factor and was outrun.
