STILLWATER STORM mid pack and inside, moved up through the second turn, got through inside of rivals into the stretch, then closed well through the lane, got through inside again the final furlong and edged ahead in the final strides. AARON'S BELT well back and outside, looped three wide through the turn while drifting out, drifted out more through the lane and got up for the place in the final strides. HOODWINKED HOLLY stalked the early pace outside, bid just outside of that one into the stretch, gained a clear lead the final furlong while drifting out and was outfinished. SAPPHERE SUE well back and inside, angled out and moved up three wide through the second turn, came four wide to bid, closed willingly through the lane and missed the show in the final strides. DEAR FAY allowed to settle, gained position on the two path through the second turn, bid between rivals into the stretch, then lacked the needed late kick. SAM'S GRINDSTONE well placed and outside, looped rivals three wide through the second turn to gain a striking position, bid on that path into the stretch and flattened out. DESIGNED TO RUN passed tiring rivals. DANCEHALL ROXIE sprinted to a clear lead soon after the start and faded the final furlong. FINAL MOMENT tracked the pace on the inside, was blocked and steadied into the stretch, then faltered. A STEWARDS' INQUIRY INTO THE RUNNING OF THE RACE RESULTED IN THE DISQUALIFICATION OF HOODWINKED HOLLY FROM 3RD TO 6TH FOR INTERFERENCE IN THE STRETCH.
