### Footnotes

PONIBOY TIME void of speed, moved up inside through the second turn, came through inside of rivals into the stretch, then closed fast the final furlong and edged ahead in the final strides. THE THIRD GUY set the early pace outside, could not go with APPEALS THE DEAL through the second turn, stayed on and held the place safe. C J MAMAS BOY second flight and inside, angled out to bid three wide into the stretch, then lacked the needed late kick. APPEALS THE DEAL vied for the early lead inside, challenged for and gained a clear lead through the second turn, then drew off in the lane, veered out inside the furlong marker and stopped. ROCKET WRENCH second flight and outside, came three wide to bid and faded in the drive. THREE DESPERADOES well back, looped rivals three wide through the second turn, then had no stretch rally. BAD BOYZ HALO steadily faded. I SIR FRISK ME NOW well placed and outside, faded quickly. MY OTHER BROTHER was no factor.
