All other purse monies paid corresponding with purse schedule in Condition Book. WEIGHT: 120 lbs. Maidens allowed 3 lbs. WINNERS PREFERRED. (Non-starters least preferred). Total earnings will be used indetermining the order of preference of horses assigned equal weights. The field will be limited to 12 horses. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A trophy will be presented to the winning owner. (S)

ESPRIT DE BLEU rushed up to gain a short lead, shook clear into the turn, then drew off in the lane while never being challenged and was kept to the task. CONGRATS AND ROSES well placed and off the rail, moved up quickly through the turn, came four wide to bid into the stretch, then drifted in under left hand urging, ran evenly the final furlong and was best of the rest. SAM'S GRINDSTONE well back and inside, angled out into the turn to move up three wide, came four wide to bid into the stretch, then lacked the needed late kick. DAZZLING MARNA well back and outside, gained a striking position four wide through the turn, fanned widest into the stretch, then got up for a share. SPEAKERS ACTION tracked the pace inside while pulling, angled out and came three wide to bid into the stretch, then drifted in and tired. GRACE OF GREATNESS well placed and inside, faded nearing the lane. CABOOSIAN LASS vied for the early lead outside and was through after a half. ALL BETS ARE OFF trailed the field.
