STAKES Minnesota Sprint Championship S. Black Type - Thoroughbred

FOR THREE YEAR OLDS AND UPWARD WHICH ARE REGISTERED MINNESOTA BREDS. Free to nominate, \$250 to pass the entry box and \$250 additional to start, with \$50,000 guaranteed (\$36,000 from Canterbury Park and \$10,000 from the Minnesota Breeders' Fund), of which \$30,000 guaranteed to the owner of the winner. All other purse monies paid corresponding with purse schedule in Condition Book. Weights: Three-year-olds, 119 lbs; Older, 123 lbs. Non-winners of \$18,000 in 2010 allowed 3 lbs; \$15,000 in 2010, 5 lbs; \$10,000 in 2009-2010, 7 lbs. (Maiden, Claiming and Starter races not considered in allowances). HIGH WEIGHTS PREFERRED (On the Scale). (Winners Preferred). Total earnings in 2009-2010 will be used in determining the order of preference of horses assigned equal weights. The field will be limited to 12 horses. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A trophy will be presented to the winning owner by Canterbury Park. Nominations closed Thursday, August 19 with 53. (S)

**Footnotes**

NOMOREWINEFOREDDIE vied for the early lead from between rivals, dueled with BIZET from the quarter pole and edged ahead late. BIZET stalked the early pace three wide, challenged for and gained a short lead into the stretch, then dueled with the winner through the lane and missed. FIRST CAPTAIN set a pressured pace on the inside, could not go with the winner into the stretch, drifted out and tired. BET YOUR BOOTS tracked the early pace off the rail, moved up through the turn on the two path, came three wide to bid into the stretch, then lacked the needed late response. MACK'S MONARCH well placed and four wide, dropped back quickly, came again through the turn and faded in the lane. TIMBER HILLS was never involved. COCONINO SLIM fractious in the gate, was a brief factor, inside.
