CLARISIMO stalked the pace along the inside, made a bid in the upper stretch and gained position in the late drive. CHAIRMAN CROOKS vied along the inside of DEADLY BLACK EAGLE, battled into the far turn, could not keep up the pace midstretch and steadily weakened. I USE TOHAVE MONEY tracked the top two leaders in the backstretch and had nothing left in the drive.
