OUR FAMILY AFFAIR rated just off the leader in the backstretch, continued a steady bid for the leader in the upper stretch, wore down foe in the final furlong and edged by to prevail. APPEALS THE DEAL set the pace in the backstretch, continued the leader in the upper stretch and began to weaken in the final furlong. GOOD GUY LARRY stalked the pace along the inside in the backstretch, saved ground along the rail in the far turn and raced along for show in the late drive. GOLD COUNTRY CAT stalked the pace in early stages and continued a steady two to three wide bid in the drive. PERFECT ABLATION saved ground along the inside and finished evenly in the stretch. READY TO ROLL raced three to four wide at the top of the lane and lacked late needed kick in the drive. EURASIAN raced five wide in the far turn and lacked response in the stretch. ERV THE BANKER showed little throughout.
