WATCH ME CLOSELY was settled along the inside in the opening half, made some progress inside rivals to draw into striking distance entering the far turn, switched off the inside to race four wide into upper stretch while making steady progress, collared SEENEMONNA T. V. in late stages and edged that foe under firm left handed encouragement. The latter raced unhurried in early stages tracking the leaders off the inside, was caught five wide racing through the backstretch. continued well outside foes to challenge nearing upper stretch, gained the lead between calls late but couldn't contain the winner. MS. CIMARRON sprinted clear of the field from the break, dictated the pace into the far turn, resisted several challenges nearing upper stretch but weakened once headed in late stages. SNOW DEVIL tracked the pace off the inside to the backstretch, split foes three wide after a half to briefly menace but flattened out in the drive. ROSIEJEWEL was held up saving ground in early stages, made a brief bid along the rail on the backstretch but emptied out early. XTRA HOPE angled in racing to the first bend, stalked the pacesetter for a half and gave way. BARBARALYNEHOGAN was a brief factor outside foes but dropped out early.
