LOBSTER MOBSTER mid pack and off the rail, gained a striking position through the turn, came four wide to bid into the stretch, then made a steady gain while drifting in through the lane and got up in time. APPEALING ZEPHYR set the early pace from between rivals, shook clear inside the final sixteenth and was outfinished. AMY'S TEARS stalked the early pace outside, bid just outside the pace setter, then weakened the final furlong. PROUD KYLEAN vied for the early lead inside, steadied hard into the turn, then was blocked into the stretch, angled out and then in for racing room and lacked a late kick. EDGY BLUE improved her position, inside. RUNAWAY GREY LADY tracked the early pace off the rail, moved to position through the turn, angled out in the stretch for clear racing room and ran evenly. NORTHERN DIAMONDS mid pack and outside, looped rivals four wide through the turn, came five wide to bid into the stretch and had no rally. STORY TIME FOLLY showed little. DEMI'S BID was a brief factor. TAHKODHA ROSE was no factor. SEA LIMIT was never involved. A CLAIM OF FOUL LODGED BY THE TRAINER OF PROUD KYLEAN AGAINST THE RIDER OF APPEALING ZEPHYR WAS NOT ALLOWED.
