All other purse monies paid corresponding with purse schedule in Condition Book. Weights: Three-year-olds, 119 lbs; Older, 123 lbs. Non-winners of \$18,000 in 2012 allowed 3 lbs; \$15,000 in 2012, 5 lbs; \$10,000 in 2011-2012, 7 lbs. (Maiden, Claiming and Starter races not considered in allowances). HIGH WEIGHTS PREFERRED (On the Scale). (Winners Preferred). Total earnings in 2011-2012 will be used in determining the order of preference of horses assigned equal weights. The field will be limited to 12 horses. Horses not drawing a starting position in the gate will receive a refund of the entry fee. Atrophy will be presented to the winning owner by Canterbury Park. Nominations closed Thursday, August 23 with 28. (S)

NOMOREWINEFOREDDIE set a pressured pace from between rivals, shook clear into the stretch, then drew off in the lane under mild urging. GOLD COUNTRY CAT well placed and inside, gained a striking position through the turn, angled out to bid three wide into the stretch, then closed willingly through the lane to get up for the place while no threat to the winner. FREEDOM FIRST well back, moved up inside through the turn, angled out slightly in the stretch for clear racing room, closed well through the lane and missed the place in the final strides. LIMO stalked the pace on the outside, could not go with the winner into the stretch, stayed on and weakened the final furlong. DANCINGWITHBIGRON passed a tiring rival. BET YOUR BOOTS pressed the early pace inside and faded.
