BRAVO PRADO sprinted to a clear lead soon after the start, increased his margin, then lasted while all out. TYMAKER well placed and between rivals, gained a striking position through the second turn, bid just outside the pace setter, then made a steady gain and hung. GRANDPA GEORGE mid pack and inside, moved up on the two path through the second turn, came three wide to bid and had a mild gain in the lane. SWEETTALK'N JUNIOR stalked the pace on the outside, dropped back into the second turn, then came again to bid three wide and evened out. HERE COMES HENRY well placed and inside, gained a striking position through the second turn, came through inside of rivals into the stretch and lacked the needed late kick. RATON PASS improved his position. BEAT YOUR BLUFF well back, looped rivals three wide through the second turn, fanned widest into the stretch and had a mild gain. THIRD RAIL passed tiring rivals. BAD BOYZ HALO well placed and three wide, faded after a half. MELBAS SLEW rushed up to contention down the backstretch

and faded quickly. SOMETHING LEGAL was a brief factor. BEAU NAMED SUE was pulled up and vanned off.
