FOR FILLIES AND MARES, THREE YEAR OLDS AND UPWARD WHICH ARE REGISTERED MINNESOTA BREDS. Free to nominate, \$250 to pass the entry box and \$250 additional to start, with \$50,000 guaranteed (\$37,000 from Canterbury Park and \$10,000 from the Minnesota Breeders' Fund), of which \$30,000 guaranteed to the owner of the winner. All other purse monies paid corresponding with purse schedule in Condition Book. Weights: Three-year-olds, 119 lbs; Older, 123 lbs. Non-winners of \$18,000 in 2011 allowed 3 lbs; \$15,000 in 2011, 5 lbs; \$10,000 in 2010-2011, 7 lbs. (Maiden, Claiming and Starter races not considered in allowances). HIGH WEIGHTS PREFERRED (On the Scale). (Winners Preferred). Total earnings in 2010-2011 will be used in determining the order of preference off horses assigned equal weights. Horses not drawing a starting position in the gate will receive a refund of the entry fee. A trophy will be presented to the winning owner by Canterbury Park. Nominations closed Thursday, August 25, with 33. (S)

BELLA NOTTE stalked the early pace outside, moved up to bid through the turn, gained a short lead in the stretch, then drew off the final sixteenth while drifting out. HIDDEN GOLD well placed and off the rail, gained a striking position through the turn, came three wide to bid into the stretch, then closed willingly through the lane and got up for the place late. CHICK FIGHT set the early pace inside, could not go with the winner in the stretch, stayed on and weakened the final sixteenth. BECKER COUNTY MISS never far back and inside, came through inside of rivals into the stretch, lost ground through the lane while holding a share. SPECIAL OCCASION was no factor.
