NEVEERRGUWITHRICHIE angled out three wide in the far turn, edged up to the lead in the upper stretch and held on in late strides. I'VE HEARD RUMORS settled in early stages, saved ground along the inside and rallied strongly in the late drive. SERA'S TUNNEL steadily gained position along the inside in the drive. MOONSHINE PROMISE forced top angle out in the upper stretch and lacked a final kick to make an impact. MORGANS A BLUMIN reserved in the backstretch, fanned out wide in the far turn and improved position in the drive. PEARLOFTHEORIENT raced three wide at the top of the lane and was no

threat. MUNDY set the pace in the backstretch, challenged in the upper stretch and weakened. SMARTY PRANCE tracked the pace in the backstretch and lacked response in the drive. PASSION TALK failed to be a threat. DINA'S TYPHOON lacked late response. HUSKER RIDGE stalked the pace in early stages and had nothing left in the drive. BUCCELLA failed to menace.
