PONI COLADA was unhurried into stride, advanced between horses through the turn, came five wide and was all out to be up in the final strides. MOYER'S POND pulled to the fore to set the pace along the inside, battled gamely through a prolonged drive but was unable to resist the winner. NORTHERN PRINCE prompted the pace between horses, assumed a brief lead with a furlong to run, kept on well but wasn't quite good enough. GLENWOOD CANYON vied three wide through a long drive but lacked the needed late response. SAM P. was forwardly placed four wide, joined the vanguard entering the stretch but weakened slightly in the final furlong. SUCCESS SUCCESS was hustled along on the inside while never far back, lost ground through the turn and went evenly through the lane. GLAMOUR GUY made a middle move to close the gap, came four wide into the stretch but came empty in the drive. BETA CAPO was allowed to settle, moved with the winner through the turn, came six wide to make a mild bid but faltered before going seven furlongs.
