STAKES Derby Trial S. Listed - Thoroughbred

FOR THREE-YEAR-OLDS. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$5,000 at time of entry. \$500 to pass the entry box; \$500 additional to start, with \$100,000 added. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight: 123 lbs. Non-winners of \$60,000 allowed 2 lbs.; a graded stakes, 4 lbs.; three races other than maiden or claiming, 6 lbs. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to winning owner.

Footnotes

MACHO AGAIN outrun early, advanced four wide on the turn, was carried in a bit in upper stretch, challenged with a furlong to go and proved best under pressure. KODIAK KOWBOY reserved early, off the inside, moved to the rail on the turn, waited from midway through the turn to the quarter mile marker, angled out for the drive, challenged between rivals with a furlong to go and held on gamely. FUJITA behind the leaders along the inside, challenged in upper stretch, gained a short lead soon after, held on well to inside the final furlong and weakened. MAJESTIC WARRIOR unhurried early, rallied in company with the winner while outside that one, drifted in a bit in upper stretch, was straightened and weakened in the final furlong. DA' TARA behind the leaders off the inside, lacked a closing bid. IRON WORKS PIKE bobbled a bit at the start, was outsprinted early, raced in the four path on the turn and could not menace. EATON'S GIFT set the pace in the three path, held well to upper stretch, drifted out late and tired. TURF WAR five wide on the turn, could not menace. LEMON SPICE forced the pace for a half in the four path and stopped.
