Footnotes

DESTREHAN hopped at the start, was unhurried into stride, closed the gap leaving the turn, angled out six wide entering the stretch, reeled in the leaders inside the furlong marker and edged clear. RUN HIDE prompted the pace between horses, forged command entering the stretch, edged clear nearing the furlong marker, continued on willingly but was unable to resist the winner. AJI settled in hand, ranged up four wide to make his bid entering the stretch, but flattened during the drive and settled for the show. GLAD CAT disputed the pace along the inside, but weakened in the final furlong and gave way. KENDALL M. D. broke slow, was allowed to settle, moved up five wide entering the stretch, but faltered in the final sixteenth and faded. JAVA FOR TWO tucked in to save ground early, angled out entering the stretch but lacked a response when called upon. SMOKIN' HOT set the pressured pace three wide, but came up empty between horses in the final furlong and retreated. UTMOST INTENSITY was allowed to settle, advanced between horses through the turn, came three wide into the stretch, bid between horses with a furlong to run, was blocked and steadied nearing the sixteenth pole and came up empty thereafter.
