CORRUPT bobbled a bit after the start, recovered to be close up along the inside, was boxed in in upper stretch, angled out a bit in midstretch and finished well late to be up in time. A. P. XCELLENT set the pace while reserved along the inside, led the field into midstretch, responded willingly when headed with a furlong to go and held on gamely but was outfinished. JAZZ QUEST pressed the pace while in hand, challenged in midstretch, gained a short lead with a furlong to go and held on gamely. MAROON reserved along the inside, improved his position while saving ground into the stretch, reached easy striking distance with a furlong to go but had no late bid. RAHYSTRADA forwardly placed while off the inside, moved out a bit once in the stretch but lacked a late bid. TERRIFIC STORM reserved off the inside, dropped back on the second turn then improved his position late. WISE RIVER unhurried three wide, had little left late. FROST GIANT within striking distance three wide, moved out a path with a quarter mile to go and tired. MURCH was outrun.
