Footnotes

EARTH SHAKER bobbled slightly and was bumped after the start, moved up to gain a slim lead just prior to leaving the chute, edged clear, repelled a bid from SHE'S GOT IT approaching the stretch and was kept to her task in the drive. DEMI COUNTRY, never far back, moved four wide around the turn when rallying, loomed menacingly outside the winner through the drive and wasn't good enough. JUDGE MARQUESA settled early, advanced between horses on the turn, ranged up inside the leaders for the last eighth but couldn't muster the needed response. SHE'S GOT IT went up early to contest the pace three abreast, was asked for her best nearing the final quarter, then weakened in the drive. RUFFAIRE leaned in at the start and bumped EARTH SHAKER. was outrun for six furlongs, circled rivals eight wide into the stretch and offered a minor gain. FRENCH REIGN, within easy striking distance while four or five wide much of the way, was empty in the drive. OCTOBER DREAMER, in behind horses for six furlongs, moved between foes five or six wide into the upper stretch and flattened out the last eighth. CHIMES LADY, outrun until the stretch, came out eight wide for the drive and failed to respond. MARIAN'S BUBBLES, forwardly placed near the inside from early on, was steadied sharply approaching the final quarter when in tight quarters along the inside, nearly lost her action and was finished. TIJUANA BRASS attended the pace from between foes early, fell back in behind the leaders on the turn and faded thereafter.
