Footnotes

KNOWNFORSTONE was unhurried into stride, wheeled out leaving the turn, reeled in the leaders and drew clear. PACIFICATOR disputed the pace two wide, edged clear with five-sixteenths to run, kept on well but was unable to match strides with the winner. BIG CAL was allowed to settle, came four wide entering the stretch, lacked room between horses, altered course further outside but failed to seriously threaten. BLINGBOY was away alertly, angled in to set the pace, but weakened entering the stretch and faded. STORM IN YOUR EYES chased three wide to the stretch and flattened out. SHERIFF BULLOCK was allowed to settle five wide and failed to respond. MYBROTHERRON dropped far back and trailed throughout.
