RED WINE vied for the early lead inside, eased back a bit before a half, came again off the rail on the second turn to challenge, gained the inside for the drive and drew off late. STEVE'S REVENGE behind the leaders, moved up three wide after a half, took over on the second turn but tired late. VERY FAIR within striking distance inside, moved up three wide on the second turn but lacked a late bid. SAVIANO steadied on the first turn in traffic, was reserved for a half, made a mild middle move but tired in the drive. GIFT COUPON outrun to the stretch, was no threat. CANDY RUN vied off the rail, took over and moved to the rail before a half, held on well to the stretch and faded. TEETEE'S TAPIT four wide on the first turn, was no factor. WICKLOW COUNTY tired three wide.
