**Footnotes**

HOLIDAY RUNNER was able to work her way inward, gained a slight lead three wide, was headed on the turn from the outside approaching the stretch by POSSE, regained the advantage nearing the final furlong, then responded gamely to left-handed encouragement to prevail. ZAVATA, outside early, maneuvered in behind horses leaving the backstretch, swung out five wide for the drive and was going well late. POSSE moved up early to force the pace from between foes, headed the winner approaching the stretch, then grudgingly weakened in the final furlong. LORD RAMBO gained a forward position, tracked the leaders four wide, continued within easy striking distance into the stretch but lacked a response. DEL DIABLO bobbed at the start, was bumped and checked, was outstripped to the lane and not a threat while improving position slightly while in behind rivals three wide. JET LOVE was sent up to force the issue early while three abreast, battled on near even terms until the stretch and weakened. SOUVENIR'S LAD, nine or 10 wide during much of the run on the backstretch, failed to rally. URIAH'S BEGINING bobbed at the start, raced seven or eight wide throughout and was empty in the drive. TITLE SHOT ducked in at the start and bumped DEL DIABLO, then failed to menace. SHELBY'S ANGEL was through early. DEVIL'S WING was outrun. RAISE AN EMBLEM, near the inside, faded early. HEART OFA CHAMPION faded on the turn while between horses.
