FOR FILLIES AND MARES, THREE YEARS OLD AND UPWARD. By subscription of \$100 each on or before April 9, 2005 or by Supplementary Nomination of \$5,000 at time of entry. \$500 to pass the entry box; \$500 additional to start, with \$100,000 added of which 62% of all monies to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Three-year-olds 116 lbs., Older 123 lbs. Non-winners of \$50,000 on the turf in 2005 allowed 2 lbs.; a sweepstakes on the turf in 2004-2005, 4 lbs.; \$24,000 on the turf since July 4, 6 lbs. If the race is moved to the main track after the time of closing, a horse may be scratched for any reason at any time up to fifteen (15) minutes prior to post time for the race preceeding this race or thereafter with a valid physical reason and approved by the stewards. The entry shall be refunded for scratches made in compliance with the above conditions. Starters to be named through the entry box at the usual time of closing. Trophy to winning owner. Closed Saturday, April 9, 2005 with 36 nominations.

Footnotes

NICOLE'S DREAM broke sharply to quickly gain a clear advantage, repelled a challenge from SPEEDY SONATA approaching the stretch, reopened a clear lead when disposing of that rival, then held sway under strong handling. MOCHA QUEEN, within striking distance and four wide to the stretch, came six wide for the drive and finished with good energy. SINGIT, between horses while outrun on the backstretch early three or four wide, circled foes eight wide into the stretch and closed a late gap. HORTENSE (CHI) settled three wide, remained near the hedge when making a run into the final furlong and failed to sustain the needed momentum. HIGH SPEED ACCESS settled soon after the break, was outrun three wide to the lane, came out a bit wider for the drive and offered a minor gain. ANNA EM, well placed in behind the leaders from early on, eased out or five wide leaving the turn and flattened out in the drive. SPEEDY SONATA chased the winner from early on while four wide, inched to challenge nearing the five-sixteenths pole but faltered when straightened into the stretch. MS. TRICK OR TREAT, close up five wide early, drifted out seven or eight wide at the five-sixteenths pole and continued wide while tiring.
