Footnotes

SKYRING closest to the pace, challenged three wide on the second turn, responded willingly when headed in midstretch and came again while fully extended. GOLDEN TICKET within striking distance three wide, made a good middle move of the rail, angled out for the drive, gained a short lead with a furlong to go but was unfinished. AGENT DI NOZZO forwardly placed off the inside, lacked a solid closing bid. WINDSURFER steadied early on the backstretch behind rivals, was reserved for a half, made a run five wide after five furlongs, reached a forward position with a furlong to go but could not sustain the bid. Z DAGER bumped at the start, angled in, was reserved for five furlongs along the inside and had nothing late late. TETRADRACHM outrun four wide, steadied when angling out leaving the second turn and in traffic then made a late gain. SCORCHER trailed for six furlongs and could not threaten. REVOLVING bumped at the start, was outsprinted early three wide and could not menace. FLEURDEFORTYFOUR set the pace off the inside, held on well for six furlongs and faded. EVENT CENTER forwardly placed three wide, moved out four wide late on the second turn and gave way.
