

RIGHT DIRECTION sprinted clear early, made the pace three wide, held on well until the upper stretch and couldn't race with TRACI GIRL thereafter as second best. GO JEANAIE GO followed the leaders four wide, remained a solid threat into the final furlong and failed to respond. SILKY SUMMER broke out and bumped the side of the gate at the start, was outrun to the stretch, then improved position while not a threat. LA BALLERINE raced near the inside and wasn't a factor. IN CASE OF WIND, well placed near the inside to the lane, faded in the drive.
