### Footnotes

CHELSEA BROOK stalked the pace three wide, drew even entering the stretch, drifted in under right handed urging, brushed KITTY'S TURN and floated that one in, was straightened away and quickly edged clear. KITTY'S TURN sped clear to set a clear pace, was collared leaving the turn, relinquished the lead with a furlong to run, was brushed and floated in, steadied and altered course nearing the sixteenth pole and fought on to just hold the place. UPON REFLECTION was allowed to settle, angled out and circled five wide, and improved position through the lane. GAMBLING DON was allowed to settle, came four wide but went evenly. SURF CAST broke a step slow, moved up along the inside, but faltered leaving the turn and dropped out. J B'S UNC broke slow, lagged at the tail of the field and trailed. The jockey of KITTY'S TURN lodged an objection against CHELSEA BROOK alleging interference in the final furlong, following the Stewards review CHELSEA BROOK was disqualified from first and placed second for drifting in and putting KITTY'S TURN in tight nearing the sixteenth pole.
