Footnotes

SARATOGA BOUND in hand early along the inside, angled out on the backstretch, made a bold three wide move into the second turn, challenged soon after running six furlongs, drew off into the stretch and stayed clear while kept to the task. BENTLEY DANIELLE angled in early when close up, saved ground into the second turn, angled out a bit for the drive, reached closest to the winner in upper stretch, could not threaten that one but held on for the place. A TIME TO LOVE alternated for the lead near the rail, lost position on the second turn, angled out for the drive and made a late gain. AUDTON unhurried for a half, steadied when in a bit tight entering the second turn, bumped STORIED, angled out and made a run four wide into the stretch but hung. STORIED within striking distance three wide, steadied when bumped entering the second turn then was no threat. DELTA LADY outrun for a half, made a bold four wide run to the three furlong marker but could not sustain the bid. SUGARSCAT behind the leaders along the inside, lacked a rally. RED VIXEN outrun for a half, raced four wide into the second turn and was no threat. FOUR POINT five wide on the second turn, was no factor. SO FLUTE alternated for the lead off the inside, took over once in the second turn but gave way in the drive.
