GRAND TRAVERSE attended the pace between horses, moved up to join the leader after a half, shook clear entering the stretch and widened. ARTURIUS broke a step slow, settled along the inside, shifted out and commenced his rally four wide, failed to menace the winner but finished willingly for the place. LAKE CREEK opened clear and angled in to set the pace, was collared after a half, was unable to match strides with the winner, weakened further and settled for the show. OUR EDGE was bumped at the start, moved up four wide, offered a mild bid leaving the turn but failed to sustain the drive. DENALI HOLY BULL settled saving ground, angled out entering the stretch but went evenly. FUTURE PROSPECT was forwardly placed along the inside to the stretch and faded. RICKS F SIXTEEN was unhurried into stride and was never a factor. MR. BUBBA CAT broke slow, bumped OUR EDGE at the start, moved up between horses but was through before going a half.
