Footnotes

BURN THE MORTGAGE close up from the start, moved closer three wide on the second turn, angled out for the drive, drifted in in midstretch when moving clear then drifted out in the final sixteenth inheriting a clear lead late. TEMERAINE outrun for a half, angled out for the drive and closed fast on the outside. QUICK WIT angled in early, steadied into the first turn inside a rival, recovered, moved up three wide on the second turn, steadied in upper stretch when blocked, angled out a bit, made a good run towards the leader in midstretch then steadied late when BURN THE MORTGAGE drifted out late losing all chance. CLASS PRESIDENT outrun inside, moved up along the rail on the second turn, angled out for the drive, raced in traffic in midstretch then was gaining when clear late. IN THE MIDNIGHT within striking distance inside, lacked room in midstretch then had no late bid. VINDICATION NOW bumped at the start, vied for the lead inside, held on well to the final furlong and weakened. POTOMAC RIVER outsprinted early, raced off the inside and was no threat. ATLANTIC TITAN forwardly placed three wide, gained a short lead on the second turn but tired in the drive. TOWNER bumped at the start, drifted out recovering, forced the pace off the inside and tired. SOUTHERN PARKWAY stumbled at the start unseating his rider. FOLLOWING A STEWARDS INQUIRY AND A FOUL CLAIM BY THE RIDER OF QUICK WIT, BURN THE MORTGAGE WAS DISQUALIFIED AND PLACED THIRD FOR INTERFERENCE IN THE STRETCH.
