COUNTY CORRECTIONS vied for the lead four wide, edged clear a furlong from home, and was kept to task to maintain a diminishing advantage. SPRING ACTION came a away a step slow, ranged into striking distance four wide, churned on through the drive and was getting to the winner. ONE MORE NIGHT was forced into the gap leaving the chute when ENLISTED MAN came in, settled saving ground, got through to make a bold bid entering the stretch but flattened during the drive and settled for the show. ENLISTED MAN vied for the early lead, veered in leaving the chute, was straightened away and disputed the issue to the stretch and tired. KEEP IT TOGETHER was allowed to settle five wide, angled in on the turn, but lacked a response when called upon. PLAYBALL TONY contended four wide, but faltered leaving the turn and retreated. R PEACE OF MIND broke a step slow and trailed.
