**Footnotes**

CENTRE COURT settled in hand off of the inside, angled in nearing the second turn, steadied with three furlongs to run, recovered quickly, weaved through traffic through the second turn, angled out finished full of run and drew away. PRETTY PLEASER was allowed to settle, launched her bid five wide, forged command with a furlong to run, but was unable to match strides with the winner. SURRENDER opened clear to set the pace, was collared nearing the furlong marker, gave way but had enough left to hold the show. RAQUEL settled saving ground, angled out leaving the second turn and improved position. RAVE REVIEWS settled in hand, moved up four wide to make her bid but flattened during the drive. AUNT PAT tucked in to save ground, slipped through to make a mild bid but faltered in the final furlong. MIZZILLI was unhurried into stride, finished with a belated gain but failed to threaten. CANNALITA settled between horses, angled out entering the stretch but came up empty in the drive. LOOK WHO'S RITZY was forwardly placed off of the inside, but came up empty between horses and retreated. BIG DEBBIE showed little. HURDLE RATE was close up four wide for five furlongs and dropped out.
