Footnotes

DREAM WARRIOR set the pace along the inside, responded willingly when challenged midway through the second turn, shook off SOUR in upper stretch, drew clear then stayed clear late. TAG V EYE forwardly placed near the rail, angled out for the drive and was gaining late. SOUR pressed the pace off the inside, challenged in earnest with five sixteenths of a mile to go, battled into the stretch but tired in the drive. LAUBURU reserved early, saved ground on the second turn but lodged only a mild late bid. BLUEGRASS JAM outrun for a half, saved ground on the second turn and could not menace. OCASTA within striking distance while in hand, was rank down the backstretch, angled out for the drive but lacked a rally. R FAST CAT unhurried three wide, was no factor. DUKE OF DEL REY within reach three wide, held on well to the stretch and faded. MAGNET COVE was no factor. WILL'S WILDCAT steadied at the start, quickly gained good position but gave way in the drive.
