GOLDLEAFED MIRROR broke fast to quickly assume a clear advantage, repelled a bid from RAINBOW'S END entering the stretch, reestablished a clear margin and was kept to her task. RAINBOW'S END chased the winner from the outset four wide, offered an earnest challenge nearing the stretch but couldn't sustain the needed momentum as second best. GOLDEN FANTASY, between horses three wide, was empty in the drive. CARINA, in contention near the inside, failed to rally. CHAMPAGNE PUNCH edged in early, stalked the pace five or six wide but was empty in the drive. SKORCH TWO, four wide, failed to reach contention. SONOMA COUNTY was outrun.
