Footnotes

CROSSWORD, fractious in the gate prior to the start, was unhurried early, eased out four wide to track front-running AMERICANREVOLUTION on the backstretch, took over just after going six furlongs, edged clear, came out approaching the finish under left-handed whipping and soundly bumped with COPY MY NOTES, forced him out and lasted. COPY MY NOTES settled near the inside early, maneuvered out four wide for the drive, had aim at the winner in the late going, then was bumped soundly by CROSSWORD and forced out nearing the finish. BROTHER BOBBY broke sluggishly and awkwardly, was used a bit early to gain a forward position four or five wide, loomed prominently for the stretch run but wasn't good enough. I'M WAITING FOR U, outrun early and angled inside, continued from the rail the remainder and bested the others. JAPENGO, never far back and four or five wide, was empty in the late going. AMERICANREVOLUTION sprinted off to a clear advantage early and gave way leaving the second turn. PIETY settled three or four wide, raced within easy striking distance to the stretch and flattened out. CHIEF EXPORT stumbled badly in his initial stride and unseated the rider. FOLLOWING A STEWARDS' INQUIRY, CROSSWORD WAS DISQUALIFIED FOR INTERFERENCE APPROACHING THE FINISH AND PLACED SECOND.
