STRADIVINSKY sprinted clear, set the pace along the inside and stayed clear under steady urging. FREE BRAVE close up along the inside, angled out for the drive, could not gain on the winner but was clearly second best. MITIGATION forwardly placed three wide, was carried six wide leaving the turn and tired. DANCE CALLER pressed the pace off the inside, drifted four wide approaching the stretch and tired. CARNACKS CHOICE reserved three wide, was no threat. PEACE TOWN bobbled at the start, recovered to race within striking distance off the inside but faded in the drive. HIGH SPIRIT was outrun.
