Footnotes

FOREST COAST rushed to the lead and angled in to set the pace, dug in to meet the challenge of MAJESTIC FALCON, battled through a long drive and narrowly prevailed. MAJESTIC FALCON broke outwardly bumping PHAT DAY, was straightened away and quick into stride, moved up two wide to engage FOREST COAST, poked his head in front leaving the turn, fought through a prolonged drive but grudgingly gave way late. TROJAN FAN was rank to place along the inside and fought restraint through the opening quarter, got through entering the stretch to make a mild bid but went evenly through the drive. PHAT DAY was bumped at the start, settled in hand three deep, came four wide and improved position through the stretch. NO TRUTH TOLD was away alertly, but caught in tight and steadied near the seven-sixteenths marker, shifted out on the turn, was forwardly placed two wide to the final furlong and faded. OUTLAW COUNTRY steadied from between horses, early, was rank to place along the inside, angled out to make a mild bid but failed to sustain the effort. FLY LUC AN EAGLE saved ground to little avail. CARSON'S DASH was pinched back at the start and passed only the tiring ones. VETERAN'S DAY was outrun. GLENDOVER was through before going a half.
