### Footnotes

SHES THAT GOOD closest to the pace, challenged three wide on the turn, drifted in under right handed pressure forcing HELLO MONDAY to steady then moved clear. HELLO MONDAY set the pace off the inside, responded willingly when challenged on the turn, battled SHES THAT GOOD into the final furlong, steadied when that one drifted in then held on to be second best. AREGULATIONHOTTIE carried out at the start, recovered to race within striking distance while off the rail, angled out for the drive but lacked a late bid. SONJA'S ANGEL drifted out at the start, raced within reach of the lead three wide but tired. WHODOESTHAT prompted the pace four wide and tired. FOLLOWING A STEWARDS INQUIRY AND A FOUL CLAIM BY THE RIDER OF HELLO MONDAY, SHES THAT GOOD WAS DISQUALIFIED AND PLACED SECOND FOR INTERFERENCE IN THE STRETCH.
